In 2020, however, the COVID-19 pandemic resulted in significantly reduced fundraising activities due to staff furloughs and only one event was held (virtually).

Club Auto: A special membership level. Members of Club Auto are provided a safe space to display their collector vehicles and share their knowledge with other automobile enthusiasts through educational speakers and car shows. During 2020, there were no Club Auto events.
